CALL TO ORDER

Mr. Dan Corey, Chair called the meeting to order at 9:30 a.m. He welcomed everyone to the September ICC meeting.

APPROVAL OF JUNE 10, 2025 ICC MINUTES

Mr. Dan Corey, Chair asked if there were any corrections or amendments to June 10, 2025 minutes. There being no changes. Mr. Sievers moved to approve June 10, 2025, minutes. Mr. Wilson seconded the motion, motion carried.

JUNE BOARD OF DIRECTORS ACTIONS

Mr. Dan Corey, Chair said the June Board of Directors meeting minutes are for information only.

TRANSPORTATION PLANNING PROGRESS REPORT

Mr. Dan Corey, Chair asked the committee members to review the monthly progress report for June, July and August. There being no comments, the progress reports for the Transportation Department were accepted.

FY2025 OKI TRANSPORTATION PLANNING YEAR END PERFORMANCE & EXPENDITURE REPORT

Mr. Bob Koehler, Deputy Executive Director, presented the FY25 Transportation Planning Year End Performance and Expenditure Report. The report is a federal requirement for MPOs. This report describes the progress made, the funds expended, and the products delivered for each of the work elements in the agency Unified Planning Work Program (UPWP). He provided a short summary of completed representative products and stated that the agency had another good year and all products promised were completed within budget.

Mr. Beck moved to recommend approval to the Executive Committee Resolution 2025-26 Concerning Acceptance of the FY2025 Transportation Planning Year End Performance & Expenditure Report. Mr. Messer second the motion, motion carried.

FY24-27 TRANSPORTATION IMPROVEMENT PROGRAM/ADMINISTRATIVE MODIFICATION #2

Mr. Andy Reser, OKI Staff, presented TIP Administrative Modification #2. Some changes to existing TIP projects are minor and only require an administrative correction to show the change in the TIP. Typically, these minor changes involve a movement of a particular phase of a project from one fiscal year to another, within the four-year planning horizon of the TIP, or a minor change in the funding amount. This

modification includes twelve highway projects in Ohio, ten in Kentucky and thirteen in Indiana. The LPA sponsor requested 10% additional OKI funds for the following projects: Anderson Township/Clough & Newtown intersection (PID 118484), Sycamore Township/School & Solzman Sidewalk (PID 119074), CVG Airport/EV Charging (PID 6-379), Highland Heights/Sunset Drive (PID 6-340), Highland Heights/US27 MUP and sidewalk (PID 6-391). Additionally, the modification includes minor revisions to funding for twelve projects, changes to thirteen Grouped Projects, and four projects with changes to the PID or moving funding among phases. The City of Mason Signals project is moving construction funding from FY27 to FY26 (PID 120730). For transit, the modification revises funding to seven Butler County RTA projects, one Cincinnati Streetcar project, one City of Middletown and three SORTA projects.

Mr. Wright moved to approve TIP Administrative Modification #2. Mr. Beck seconded the motion, motion carried.

FY26-29 TRANSPORTATION IMPROVEMENT PROGRAM/AMENDMENT #2

Mr. Andy Reser, OKI Staff, said the Amendment for FY26-29 reflected in the proposed resolution includes additions and funding changes to sixteen highway projects and four transit projects. Notably, the amendment adds the PE phase to four EV charging projects, adds the right-of-way phase to Phase 1 of the Ohio River Trail, adds the federal RAISE grant for the Covington Central Riverfront Project and adds two INDOT slide correction projects in Dearborn County. All projects are exempt from air quality conformity requirements.

Mr. Johnston moved to recommend approval to Executive Committee Resolution 2025-28 Concerning Amendment #2 of the Fiscal Years 2026 – 2029 Transportation Improvement Program. Mr. Wilson seconded the motion, motion carried.

OTHER BUSINESS

Ms. Robyn Bancroft, OKI Staff, announced the Ohio Statewide Freight Plan Survey with a deadline of September 19.

Mr. Corey, Chair, announced the Prioritization Subcommittee will meet immediately following ICC with a Repaving Pilot workshop after that.

EXECUTIVE COMMITTEE ACTIONS

September 11, 2025 – 10:30 a.m.

Executive Committee Meeting Minutes

Ohio-Kentucky-Indiana Regional Council of Governments

Attendance record for OKI board members along with quests and staff follows the minutes.

Item #1A Administrative

President Josh Gerth called the meeting to order at 10:32 a.m. He noted today is 9/11, a somber day and asked for a moment of silence. Resident Member and Veteran, Tom Voss led the Pledge of Allegiance.

President Gerth announced that there are two new members to OKI board of directors. The first being Metro's seat is now filled by Andrew Aiello, CEO and General Manager due to Darryl Haley's retirement. Additionally, The Planning and Development Services of Kenton County also has new representation due to Sharmili Reddy becoming the city manager for the City of Covington. The new executive director of PDS of Kenton County is Joshua Wice who will represent PDS; he was present for the meeting.

President Gerth reminded everyone that the Much in Common happy hour was happening after work today at TQL Stadium. He encouraged members to attend the free bipartisan event and hear from Jeff Berding, the Co-CEO of the FC Cincinnati soccer club. The Much in Common program will move around to different locations within the OKI region, to help promote what OKI does and to celebrate the efforts of those serving in the communities.

Item #1B Approval of June 12, 2025, Board of Directors meeting minutes

President Gerth requested approval of the June 10 Board of Directors meeting minutes as distributed. Trustee Shannon Hartkemeyer, Butler County Association of Township Trustees & Clerks provided a motion with a second from council member Floyd Croucher, City of Trenton; motion passed.

Item #1C CEO's Report

OKI CEO Mark Policinski shared that Sam Wallace will present the FHWA findings of the recertification review and he noted it is important because without a positive review, OKI cannot provide funding to jurisdictions via federal grants.

He shared that he recently had a meeting with Larry Krauter, the new CEO of CVG and stressed that Larry values the partnership with OKI and understands the unique value OKI has to CVG and how important CVG is to the region.

Mr. Policinski next stated that staff have been working on the prioritization process (for funding projects) and that \$80 million will be granted to jurisdictions in the OKI region. He noted that for the past 22 years, the board of directors have unanimously approved on how to spend the funds. Additionally, he noted that for a variety of reasons, there were several projects that were going

to be delayed, and this would have caused a build up of unspent funds. Instead of having those projects sit, the OKI staff have devised a new round of funding specifically for resurfacing projects, almost \$14 million will be available.

Item #1D Finance Officer's Report

Director Hannum stated that June 30th ends OKI's fiscal year. She noted that the report contains May and June financial statements, but she will be reporting only on the June financial statements along with current cash information. As of September 5, 2025, OKI had:

\$772,738 - PNC Bank Commercial Checking Account \$7,886 - PNC HSA/FSA Checking Account \$1,034,994 - STAR Ohio Money Market Mutual Fund Account

Director Hannum reported there has been no recent activity on OKI's line of credit, and that there is no outstanding balance at report date. She further reported on Balance Sheet, Revenue and Expense information.

President Gerth requested a motion to approve the financial report. Commissioner Stephanie Summerow Dumas, Hamilton County provided a motion with a second from Commissioner T.C. Rogers, Butler County; motion passed.

Item #2 Federal Certification Review

Mr. Sam Wallace, Community Transportation Planner with FHWA Ohio Division provided highlights of the agency's Transportation Management Area Federal Certification Review that was held in late 2024. He stated that for the planning process, OKI complies with the spirit and intent of the federal metropolitan planning laws and regulations and officially certified for the next four years. He additionally stated that OKI is a mature, well-established, and successful MPO with no recent history of corrective action and with positive findings. There were six noteworthy practices that received commendations, they are as follows: Housing Data Dashboard, Congestion Management and ITS, the oki.org website redesign, GIS upgrades, The Freight Plan and Regional Transit Collaboration.

Item #3 OKI FY2025 Transportation Planning Year End Performance and Expenditure Report

OKI staff, Bob Koehler stated that one of the federal requirements is a year-end report, which is a compilation of monthly progress reports. He said that the agency met more than 100 products along with 47 products from OKI's transit partners. He proceeded to share some examples of the products, including a new transportation improvement program, housing dashboard, green space

environmental mapper, fiscal impact assessment model, 5310 program and the Boone County transportation plan.

President Gerth requested a motion for OKI Resolution 2025-26. A motion was provided by Commissioner David Painter, Clermont County with a second from Commissioner T.C. Rogers, Butler County; motion passed.

Item #4 Amendment of Current Compensation Plan

CEO Mark Policinski stated the OKI compensation plan is for non-contract employees, which is everyone except himself and has worked well for the past twenty years. He said the system balances fiscal responsibility, fairness to staff and competitive marketplace.

He noted that the compensation system is flexible and there comes a time to make adjustments, the last adjustment was twenty years ago. He proceeded to share that the compensation system is divided into bands into which every job is categorized. Entry level is band one and senior level is band five. Each band has a minimum and maximum salary level. Even though the maximum salary is adjusted for inflation, after twenty years, it is necessary to increase the maximum salary of each band. Without the adjustment, long-term employees are disadvantaged.

He shared that this adjustment will only affect one staff person, that adjustment will add 8 one-ten-thousandth of a percent of OKI's salary expenditures. The resolution would expand the bans by 5% and increase in the future up to 5% in a year if warranted. Any further expansion would require approval of the budget committee.

President Gerth requested a motion for OKI Resolution 2025-27. Commissioner T.C. Rogers provided a motion with a second from Vice-Mayor Julie Smith-Morrow, City of Newport; motion passed.

Item #5 – Intermodal Coordinating Committee Report

OKI staff, Mr. Andy Reser provided a brief update of the ICC meeting held on September 9, 2025. He said that the committee heard information on the Transportation Planning progress reports and the Transport Ohio stakeholder survey. Additionally, the committee recommended approval of resolutions for the FY25 Year End Performance and Expenditure Report and TIP Amendment #2. He also noted the committee approved a TIP Administrative Modification. He said after the meeting, the prioritization subcommittee met to discuss the draft scored of project applications for the new OKI federal transportation funding with recommendations for awards presented to the OKI board of directors at the October meeting.

Mr. Reser also noted that a TIP item was received late and did not make it on the agenda for TIP modification. It was a change submitted by KYTC for commitment of additional federal bridge

funds to fill a \$16 million gap in funding for the 4th Street Bridge replacement project over the Licking River. He said the TIP modification allows progress on the project without interruption.

Item #6 - Amendment #2 to the OKI Fiscal Years 2026-2029 Transportation Improvement Plan

Mr. Andy Reser said that Amendment #2 contains 16 highway projects and 4 transit projects. They are as follows:

- Adds detailed design, environmental or right of way phases to 4 EV charging projects in West Chester (PID 122830), Union Twp (PID 122828), New Richmond (PID 122829), and Cincinnati OTR (PID 122817)
- Brent Spence Bridge, phase 2 (PID 113661) moves all construction funds beyond FY29
- Adds right of way & construction phases to I-275 Smart Lane project from US42 to Clermont County (PID 115417)
- Adds right of way phase to phase 1 of Ohio River Trail Oasis line (PID 122971)
- Warren County -adds safety project at US 42/Middletown Road intersection
- Adds NEVI (national EV charging infrastructure) project for 3 locations in Boone County
- Adds design, right of way, utilities phases to the Covington West 15 Street bridge project (6-1070)
- Adds federal RAISE grant for Covington Central Riverfront project
- Adds two INDOT slide correction projects along I-74 in Dearborn County

And for Transit - Adds projects for BCRTA, Cincinnati Streetcar and TANK

President Gerth requested a motion for OKI Resolution 2025-28. Trustee Shannon Hartkemeyer, Butler County Association of Township Trustees & Clerks provided a motion with a second from Resident Member Roger Kerlin; motion passed.

SEPTEMBER 2025

Short Range Planning (601)

Staff continued to help communities learn more about Transportation Alternative options and funding mechanisms.

Staff presented applications and draft scores at Prioritization Meeting.

<u>Transportation Improvement Program (602)</u>

Staff continued to monitor projects with OKI allocated federal funds.

A FY26-29 TIP Administrative Modification was presented and approved at the September ICC meeting. A FY26-29 TIP Amendment was presented and approved at the September Executive Committee meeting. A TIP Administrative Modification for Ohio group projects was approved in the ODOT e-STIP system. A draft TIP Amendment and TIP Administrative Modification was prepared for the October ICC and Board of Directors meetings.

For the 2025 Project Prioritization Process, the draft scores were presented to the prioritization subcommittee following the September ICC meeting. Funding recommendations will be presented at the October ICC and Board of Directors meetings.

The draft October TIP Amendment was posted on the website for public review and comment.

The Annual Listing of Obligated Projects (ALOP) report for Ohio and Indiana was completed. The Kentucky ALOP report will be completed in December.

Surveillance (605.1)

Staff monitored and performed quality control of ORBCS data.

Staff continued coordination with TEC and KYTC, planning traffic counter maintenance and new traffic counter installation.

Staff completed bulk processing of traffic count data obtained from ODOT for Butler, Warren, and Clermont counties.

Staff began updating traffic count database with recent count data for Boone, Kenton, and Campbell counties.

Staff continued calibration and initial validation of the mode choice module.

Staff generated turning movement volume forecast for a traffic impact study at SR 48 & Lytle Five Points for TEC and ODOT.

Staff developed traffic growth estimates for SR 131 between SR 132 and Greimann Ln for Clermont County and ODOT.

Staff prepared traffic forecasts and reviewed traffic growth estimates within the IR 471/IR 275 interchange planning study area for KYTC.

Staff updated the Regional Residential Development Inventory.

Staff continued reviewing parcel land use categories for overall housing unit inventory

Staff continued work on Demographic Data Dashboard for the OKI Website.

Staff attended the Ohio GIS Conference in Columbus, OH on September 14-16.

Staff attended the Kentucky GIS Conference in Florence, KY on September 24-25.

Staff initiated participation in the ESRI Survey 1-2-3 beta program, which focuses on testing AI-generated descriptions and data extraction for photos captured during field data collection activities.

Staff presents the amendment to the Intermodal Coordinating Committee (ICC), the ICC considers the issue and makes a recommendation to the Board of Directors. Any public comments will be presented to the Board of Directors prior to scheduled action.
