FY26-29 TIP Administrative Modification 2

- Highway (12 projects in OH, 10 in KY, 13 in IN)
 - LPA request to add 10% additional OKI funds
 - Anderson Twp. Clough & Newtown intersection (PID 118484)
 - Sycamore Twp. School & Solzman Sidewalk (PID 119074)
 - CVG Airport EV Charging (PID 6-379)
 - Highland Heights Sunset Drive (PID 6-340)
 - Highland Heights US27 MUP and sidewalk (PID 6-391)
 - Minor revisions to funding
 - 12 projects
 - 13 Grouped Projects
 - 4 - Change PID or move funding among phases
 - Mason Signals project – move funds from FY27 to FY26 (PID 120730)
- Transit (7 BCRTA, 1 Cincinnati, 1 Middletown, 2 CTC, 3 SORTA)

FY26-29 TIP Amendment #2

- 16 Highway Projects, 4 Transit Projects
- Adds DD/ENV or RW phases to 4 EV charging projects in West Chester (PID 122830), Union Twp (PID 122828), New Richmond (PID 122829) and Cincinnati OTR (PID 122817)
- HAM IR 75 between Linn – Findlay BSB Ph2 (PID 113661) Moves all CO funds beyond FY29.
- Adds RW & CO phases to I-275 Smart Lane project from US42 to Clermont County (PID 115417)
- Adds RW phase to Phase 1 of Ohio River Trail – Oasis line (PID 122971)
- Warren County-adds safety project at US 42/Middletown Road intersection
- Adds NEVI project for 3 locations in Boone County
- Adds D/RW/UT phases to the Covington West 15th Street bridge project (6-1070)
- Adds federal RAISE grant for Covington Central Riverfront project
- Adds two INDOT slide correction projects along I-74 in Dearborn County
- Transit - Adds projects for BCRTA, Cincinnati Streetcar and TANK
